**ADMINISTRATIVE ORDER NO. 2014-06**  
**SPIRIT PRODUCT DISTRIBUTION REQUEST**

Skyy Spirits, LLC (vendor of spirits), at the above-noted location, has acquired Forty Creek Barrel Select whiskey brand from Monsieur Henri Wine Co. (vendor of spirits). Skyy Spirits, LLC has an existing written agreement or contract with an Authorized Distribution Agent (ADA). Skyy Spirits, LLC has submitted a written request for permission to distribute this new brand through their existing ADA, General Wine and Liquor Company, Inc., effective August 3, 2014.

Under Article IV, Section 40, of the Constitution of Michigan (1963), the Commission shall exercise complete control of the alcoholic beverage traffic within this state, including the retail sales thereof, subject to statutory limitations. MCL 436.1201(2) provides the Commission with the sole right, power, and duty to control the alcoholic beverage traffic

and traffic in other alcoholic liquor within this state, including the manufacture, importation, possession, transportation and sale thereof.

After reviewing the request and discussion of the issue at the meeting, the Commission finds that based on the information received this request should be approved.

THEREFORE, IT IS ORDERED that:

- A. The request made by Skyy Spirits, LLC to distribute Forth Creek Barrel Select whiskey through General Wine and Liquor Company, Inc. effective August 3, 2014 is hereby APPROVED.
- B. Skyy Spirits, LLC and General Wine and Liquor Company, Inc. shall submit an executed Addendum to Schedule A of the ADA contract by May 23, 2014 to prevent delays for this brand.
- C. Skyy Spirits, LLC shall file the appropriate product changes in the Commission's E-Quote system by May 23, 2014 to prevent delays for this brand.
