Commissioner Quimby called the hearings to order at 10:08 a.m. noting a quorum was present.

1. Moved by Commissioner Quimby, supported by Commissioner Olshove, that the minutes of the Southfield Appeal Hearings of July 11, 2013, be approved as written and presented, motion carried by unanimous vote.
2. D & M Toma, Inc., D/B/A Lunch & Liquor Party Store, 1424 Ecorse, Ypsilanti Township, Washtenaw County Business ID# 160835

The penalty hearing was conducted for D & M Toma, Inc., Business ID# 160835. Linda Pytel-McDowell appeared on behalf of the Attorney Generals Office, Attorney Joseph A. Shallal and Diana Toma, President, appeared on behalf of the licensee. Ms. Pytel-McDowell, Mr. Shallal and Ms. Toma offered comments regarding this case. After discussion on the record, Commissioner Quimby made a motion to suspend the licenses for seven (7) consecutive days starting on July 29, 2013, as set forth in the Penalty Hearing Order. Commissioner Olshove supported, and the motion was carried by unanimous vote.

2. Char Bar-Fenton, LLC, 201 S. Leroy, Fenton, Genesee County
Request ID# 669383

The licensing hearing was conducted for Char Bar-Fenton, LLC, Request ID# 669383. Linda Pytel-McDowell appeared on behalf of the Attorney Generals Office, Attorney Neil Wallace, and Erich Lines, manager, appeared on behalf of the applicant. Ms. Pytel-McDowell and Mr. Wallace offered comments regarding this case. After discussion on the record, Commissioner Quimby made a motion to reverse the previous Commission Order of denial dated April 24, 2013, and approve a request to transfer ownership of escrowed 2013 Class C license from Macy's

Retail Holdings, Inc., transfer location (governmental unit) under MCL 436.1531(1) from G-4600 Miller, Flint, Flint Township, Genesee County and request a new Specially Designated Merchant license, as set forth in the Licensing Appeal Order. Commissioner Olshove supported, and the motion was carried by unanimous vote.

4. Mackeys Inc., 4328 Oakwood, Melvindale, Wayne County Request ID# 661986

The licensing hearing was conducted for Mackeys Inc., Request ID# 661986. Linda Pytel-McDowell appeared on behalf of the Attorney Generals Office, Attorney Scott MacDonald, and Attorney D. Todd Williams, appeared on behalf of the applicant. Ms. Pytel-McDowell and Mr. MacDonald and offered comments regarding this case. After discussion on the record, Commissioner Quimby made a motion to reverse the previous Commission Order of denial dated May 8, 2013, and remand the file back to the Licensing Division for further review. Commissioner Olshove supported, and the motion was carried by unanimous vote.

5. Bossy B's Bar & Grill Inc., 14700 E. Seven Mile, Detroit, Wayne County Request ID# 672380

The licensing hearing was conducted for Bossy B's Bar & Grill Inc., Request ID# 672380. Linda Pytel-McDowell appeared on behalf of the Attorney Generals Office and no one appeared on behalf of the applicant. Ms. Pytel-McDowell offered comments regarding this case. After discussion on the record, Commissioner Quimby advised this matter would be tabled to a hearing on a future date.

With no further business, moved by Commissioner Quimby, supported by Commissioner Olshove, that the Appeal Hearings be adjourned at 11:35 a.m., motion carried by unanimous vote
