A request for reconsideration of the server training requirement as outlined in the licensing approval order dated March 23, 2011. The licensee is required to provide proof of successful completion of a Commission approved server training program for the stockholder and all employees involved in the sale and service of alcoholic beverages under MCL 436.1501.

Moved by Chairman Deloney and supported by Commissioner Quimby that the server training requirements be amended to require the licensee to provide documentary proof to the Commission to demonstrate:

- that, at a minimum, supervisory personnel on each shift and during all hours alcoholic beverages are served have successfully completed a server training program approved by the Commission;

- that the licensee maintain active certification of successful completion of server training on the licensed premises at all times;
- and that failure to provide documentary proof that, at a minimum, supervisory personnel on each shift and during all hours in which alcoholic liquor is served have successfully completed a server training program approved by the Commission shall result in the licensee being charged with failure to comply with the amended licensing approval order.
