MOTION: It was moved by Mr. Benson and supported by Mr. Viviano that the following penalty be assessed: Dissolve the current Summary Suspension and Cease and Desist order against Respondent's Professional Boxing license; 90 days suspension of Respondent's Professional Boxing license; a civil fine in the amount of \$2,500.00 made payable to the State of Michigan within sixty (60) days from the date of mailing of the Final Order for Complaint No. 323921. If the civil fine has not been paid within sixty (60) days from the date of mailing of the Final Order, then the Respondent's Professional Boxing license shall remain suspended until the civil fine is paid in full. The motion carried by unanimous vote.
