Furthermore, Respondent shall provide written evidence from the Health Professional Recovery Program (HPRP) verifying that Respondent has entered into a disciplinary non-confidential monitoring agreement and that the HPRP has endorsed Respondent as safe to practice or that the HPRP has determined that Respondent does not require treatment monitoring.

Upon reinstatement, Respondent shall be placed on probation for a period of one (1) year on the effective date of automatic reinstatement and must comply with her terms of the HPRP monitoring agreement.

In the event Respondent's license remains suspended for more than six (6) months, Respondent shall file an application for reinstatement of the suspended license.




