During the period of limitation, Petitioner is prohibited from holding ownership/financial interest in any pharmacy. Petitioner must petition for reclassification of the limited license. In addition, Petitioner is placed on probation to run concurrent with the period of limitation. The terms of probation require that Petitioner does not violate the Public Health Code, in the matter of Alice Hinnawi, R.Ph.






