## **REGULATORY CONSIDERATIONS**

### **LISA ANN HAMZIK, AUDIOLOGIST – PETITION FOR REINSTATEMENT**

**Motion** by Mukkamala, seconded by Korpela, to grant reinstatement to a full and unlimited license, in the matter of Lisa Ann Hamzik, Audiologist.

**Motion** by Mukkamala, seconded by Kauffman, to place Respondent on probation for a period of one (1) year with the following terms and conditions:

- 1) Respondent shall report to the Department, in writing, any and all changes in Respondent's employment within fifteen (15) days of such change if Respondent's employment change requires Respondent to have an audiologist license. Respondent shall provide copies of this Order and the Complaint dated November 26, 2008, to each successor employer and supervisor, if the employment requires Respondent to have an audiologist license.
- 2) If at any time during the period of probation Respondent is not employed as an audiologist, Respondent shall file a report of non-employment with the Department within fifteen (15) days after becoming unemployed. Respondent shall continue to file a report of non-employment on a quarterly basis until Respondent returns to employment as an audiologist, at which time Respondent shall notify the Department of this fact within fifteen (15) days of returning to practice.
- 3) Periods of residency and practice outside Michigan shall not reduce the probationary period of this Order. Respondent shall report any changes of residency or practice outside Michigan no more than fifteen (15) days after the change occurs. Compliance with this provision does not satisfy the requirements of sections 16192(1) and 16221(g) of the Public Health Code, *supra*, regarding Respondent's duty to report name or mailing address changes to the Department.
- 4) Respondent shall comply with the Public Health Code.


