Respondent's license to practice chiropractic in the state of Michigan will be limited for a minimum period of ONE DAY, not to exceed one year. The license shall be limited as follows:

1. **PRACTICE:** Respondent shall not use or delegate the use of the on-site x-ray facility until corrective measures have been taken to ensure compliance as directed by the Bureau of Health Systems, Radiation Safety Section.
2. **COMPLIANCE:** It shall be Respondent's responsibility to ensure that satisfactory written evidence of his compliance with the Bureau of Health Systems, Radiation Safety Section is sent to the Department.

Respondent's license shall be automatically reclassified to a full and unlimited status upon receipt by the Department of Community Health, of satisfactory written evidence from the Bureau of Health Systems, Radiation Safety Section, verifying that Respondent has taken corrective measures to address the cited deficiencies, and that the x-ray facility ensures the safety of patients and staff.
