Key Responsibilities

- Publishes standards for municipal, county, state, tribal, railroad, airport, public university, public college, and park law enforcement officers.
- Publishes curricula and administers a statewide law enforcement basic training delivery system composed of 20 academies.
- Approves and supervises basic police training programs, as well as pre-service college basic training programs.
- Administers a law enforcement pre-enrollment testing program operated by approved basic training academies.
- Supports law enforcement training efforts through administration of the Training to Locals Fund, which reimburses local police agencies for a portion of the costs of basic law enforcement training.
- Maintains a statewide registry of Michigan's law enforcement agencies and licensed law enforcement officers.
- Administers the Stop Violence Against Women grant program for law enforcement.
- Verifies standards and licenses officers for law enforcement service in Michigan and conducts revocation proceedings to remove those who are unfit.
- Administers the Justice Training Fund which offers a competitive grant program and annual distribution of funds to assist law enforcement agencies with the costs of in-service training.
- Certifies instructors and training programs provided by law enforcement entities pursuant to Michigan's concealed weapons laws.
- Develops, maintains, and administers the state licensure examination.
