**REQUIRED MINIMUM ENTRANCE QUALIFICATIONS; OTHERS WILL BE REJECTED**

**AT THE TIME OF APPLICATION, AN APPLICANT MUST**

1. Be a citizen of the United States..
2. Associates degree mandatory; Bachelors degree from accredited university will receive preference.
3. M.C.O.L.E.S. certified or certifiable will receive preference.
4. Have at least 20/40 vision in each eye, correctable to 20/20 vision.
5. Have normal hearing in each ear.
6. Never have been convicted of:
  - a. A felony
  - b. Operating under the influence of intoxicating liquor or drugs.
  - c. Two moving violations within the 24 months previous to application.
  - d. Reckless driving offense.
7. Possess a valid Michigan operator or chauffeur license.
8. Not have been suspended, demoted, discharged or asked to resign from a police position as the result of disciplinary action or because of criminal conduct.
9. Never had operator's license suspended, revoked or denied.
10. Sign a two year agreement
11. A copy of the following documents must accompany the completed application:
  1. Résumé
  2. College transcript & diploma
  3. M.C.O.L.E.S. Pre-employment test results

**EXAMINATION CONTENT**

To evaluate the candidate's ability to hold the position of police officer.

Oral Interview 60%                      Written test 40%

1. All applicants must pass a physical exam to prove freedom from any physical or mental defects, deformities, or diseases which might incapacitate the applicant from the performance of the duties of police officer.
2. A background investigation shall be conducted to evaluate the applicant's employment, school, home, medical, credit, criminal, driving or other personal records. In addition, all candidates will be fingerprinted.

**NOTE:**        Candidates must pass the written and oral portions of the selection process with a minimum passing score of 70%. All requirements, including the medical examination and background investigation, must be successfully passed in their entirety to enable a candidate to be selected from the eligibility list.

**PURPOSE**

The purpose of this examination is to establish an eligibility list from which present and future vacancies will be filled, in this classification, in the Township Police Department. For each vacancy, the appointing authority shall select only persons from the Civil Service list.
