

2010 *Learn and Serve - Michigan Outstanding Service-Learning Awards*

Recognizing service-learning excellence in Michigan!



A service-learning practitioner or teacher will be recognized for leadership and helping others expand service-learning activities.



A K-12 service-learning program will be recognized for demonstrating innovation and excellence.



A service-learning student will be recognized for demonstrating leadership in the development and implementation of service-learning in his/her district.



A service-learning administrator will be recognized for demonstrating and helping support practitioners in the field through policy and resources.

Service-learning is a way of teaching that connects learning with meaningful service to the community. In Michigan, service-learning continues to grow due to the hard work and commitment of educators, administrators, students, and nonprofit professionals. For this reason, the Michigan Community Service Commission (MCSC) is pleased to present the **2010 Learn and Serve - Michigan Outstanding Service-Learning Awards**. These awards recognize the very best in Michigan's service-learning community. Four awards will be given--one to a teacher/practitioner, one to an innovative service-learning program, one to a school administrator, and one to a student.

Nominations for these prestigious awards may be submitted by anyone familiar with service-learning philosophies, such as co-workers, school administrators, students, family, and friends. Self-nominations are also accepted.

NOMINATION PACKET

A completed Service-Learning Awards nomination packet contains the following components:

I. Nomination Cover Sheet

The Nomination Cover Sheet is one page single-sided. Please type or print neatly. The cover sheet may be duplicated or a computer-generated likeness may be created.

II. Nomination Narrative

The Nomination Narrative is three single-sided pages and is used extensively by the reviewers when selecting the award recipients. The narrative should be written specifically to the category for which the nominee is being nominated and should answer the questions outlined under "Nomination Narrative Information" in each category description. (See page 3 and 4 for details.)

The Nomination Narrative should be written using the following format:

1. Three pages (single-sided)
2. Typed or neatly printed
3. 12-point font or larger
4. Double-spaced
5. One-inch margins

III. Reference Letters

Nominators should submit no more than three letters of reference with the nomination packet.

The reference letters should be provided from individuals/organizations to support the information provided in the nomination. Two of the letters should come from outside of the nominee's organization/school.

IV. Support Material

One 8 1/2" x 11" page of supporting materials may be included in the nomination packet. This could include a newspaper article, photographs, brochure, etc. Audio or video tapes, display materials, scrapbooks, etc. will not be accepted. All supporting documentation must accompany the nomination form. Supporting documentation received separately from the nomination packet will not be considered. Supporting materials will not be returned.

NOMINATION DEADLINE

Nominations must be received by the Michigan Community Service Commission no later than **5:00 p.m. on Monday, November 30, 2009.**

SUBMITTING A NOMINATION

The nomination information should be arranged in the following order and stapled:

- 1) Nomination Cover Sheet
- 2) Nomination Narrative
- 3) Reference Letters
- 4) One Page of Support Material - if available

SELECTION PROCESS

One award winner will be selected in each category by a panel of service-learning leaders.

NOTIFICATION

The MCSC will confirm receipt of nominations by email by Tuesday, December 1, 2009 if the nominator provides his/her email address on the nomination cover sheet.

The award winners will be selected and notified by Friday, December 18, 2009.

AWARD CATEGORIES

Administrator Award

The 2010 School Administrator Award will be presented to an administrator who has served as a model of leadership for service-learning. This awardee helps support practitioners in the field through policy and resources. S/he must have demonstrated a vision for service-learning and advanced the practice through education and advocacy.

Nomination Narrative Information for the Administrator Award

Please provide the following information in the Nomination Narrative (See page 2 for other details about the Nomination Narrative.)

- 1) Explain, with examples, how your nominee has served as a model of leadership, helping to support practitioners in the field through policy and resources.
- 2) Describe how your nominee has demonstrated a vision for service-learning.
- 3) Describe how the nominee has demonstrated an impact on the field of service-learning in a minimum of two of the following areas:
 - Policy development
 - Advocacy
 - Education
 - Professional development
 - Links to other school initiatives
 - Partnership development
 - Successful replicable program models

Innovative Program Award

The 2010 Innovative Program Award will be presented to a K-12 service-learning program that demonstrates innovation and excellence. The program should incorporate key elements of high-quality service-learning, and have a sustainable impact on the participants and the community. Nominations from K-12 service-learning programs in which the service-learning is part of the classroom are eligible. Although the word "program" is used, nominations will be accepted for a particular "project" as long as it has a long-term impact. Programs and projects that are ongoing will receive priority.

Nomination Narrative Information for the Innovative Program Award

Please provide the following information in the Nomination Narrative (See page 2 for other details about the Nomination Narrative.)

- 1) Describe the program or project, including how it incorporates the K-12 Service-Learning Standards for Quality Practice. Answer the following questions:
 - What meaningful community need was addressed and how was it identified?
 - What service occurred in response to this need?
 - How was the project linked to what students were learning in the classroom?
 - Did you partner with groups or organizations in the community?
 - What methods did you use to reflect on the experience?
 - How did you evaluate the impact of the project on the student participants and the community?
- 3) In what ways did youth act as leaders throughout the experience? (For example: conducted the interviews that assessed the community need, planned the project, etc.)
- 4) How did the program impact the young people who participated, and how did it continue to impact them afterward?
- 5) How did the project make a difference in the community, and how does it continue to make a difference? (Please include quantifiable data. For example: 253 flowers were planted; 562 meals were served.)

Student Award

The 2010 Student Award will be presented to a student who has served as a model of leadership. The nominee must have demonstrated leadership in the development and implementation of service-learning in his/her district. The nominee must have demonstrated initiative and creativity in service-learning participation. This awardee must have engaged in service-learning that resulted in a positive impact on his/her school or community.

Nomination Narrative Information for the Student Award

Please provide the following information in the Nomination Narrative (See page 2 for other details about the Nomination Narrative.)

- 1) Explain, with examples, how your nominee has served as a model of leadership for other students engaged in service-learning.
- 2) Describe how your nominee has demonstrated initiative and creativity in their service-learning efforts.
- 3) Describe how the school and/or community has been impacted as a result of the student's involvement.
- 4) Describe how the student has been positively impacted by their involvement in service-learning.

Teacher/Practitioner Award

The 2010 Teacher/Practitioner Award will be presented to a teacher who has served as a model of leadership. This awardee implements their own project and helps nurture others to expand their service-learning knowledge and skills. The nominee must have demonstrated the ability to incorporate the K-12 Service-Learning Standards for Quality Practice, and have provided youth opportunities to lead and serve.

- 1) Explain how your nominee linked their service projects to what the students were learning in the classroom.

- 3) How has your nominee supported youth opportunities to lead and serve?
- 4) Describe how the nominee has demonstrated an impact on the field of service-learning in a minimum of two of the following areas:
 - Curriculum development
 - Links to other school initiatives
 - Partnership development
 - Successful replicable program models
 - Professional development
 - Policy development
 - Advocacy
