Directions to Agro-Culture Liquid Fertilizer in St. Johns

From the North – Take W M-21/M-21. Continue to follow W M-21. Turn left onto S Dewitt Rd. for 0.04 mi. Arrive at 3055 W M 21.

From the South - Take **US-23 N** toward Ann Arbor. Merge onto **I-96 W** (via EXIT 60B on the left toward Brighton/Lansing) for 41.0 mi. Merge onto **I-496 W/US-127 N** (via EXIT 106B toward Downtown Lansing) for 3.6 mi. Keep right to **take US-127 N** (via EXIT 8 toward Clare) for 18.8 mi. Take the **M-21** exit, (EXIT 96, toward St Johns/Owosso). Turn **left** onto **E M-21/M-21**. Continue to follow E M-21 for 3.4 mi. Turn left onto S Dewitt Rd. for 0.04 mi. Arrive at 3055 W M 21.

From the East – Take I-69 W toward Lansing, then (take exit 123) M-13 N (turn right) (go 2.3 miles). Turn left onto M-21/E Corunna Rd. Continue to follow M-21 for 33.1 miles. Turn left onto S Dewitt Rd. for 0.04 mi. Arrive at 3055 W M 21.

From the West – Take **I-196 E** toward Grand Rapids. Merge onto **M-6 E/Paul B Henry Fwy** (via EXIT 64 toward Lansing) about 18.9 mi. Merge onto **I-96 E** (toward Lansing) for 21.5 mi. Take the **M-66** exit, (EXIT 67, toward Ionia/Battle Creek) for 0.4 mi. Turn **right** onto **M-66 S/S State Rd.** for 0.2 mi. Make a **U-turn** onto **M-66 N**. Go about 7.9 mi. Turn **right** onto **W Lincoln Ave/M-21**. Continue to follow M-21 for 25.6 mi. Turn right onto S Dewitt Rd. for 0.04 mi. Arrive at 3055 W M 21.
