While notification under the Worker Adjustment and Retraining Act (WARN) is not required in this case, we want to give you notice that Allied Systems, Ltd., will be permanently closing its terminal operation at 36555 Michigan Avenue, Wayne Michigan on August 18, 2008. This will result in the layoff of all positions. The total number of positions affected is 29. We are enclosing for your information a list of the job titles and number of employees in those positions who will be affected.

Affected bargaining employees will be laid off on August 18, 2008, and there will be no bumping rights at the Terminal. Teamsters Local Union 299 represents the bargaining employees.
