Subject: Notice of Mass Layoff Pursuant to the WARN Act

Pursuant to the Worker Adjustment and Retraining Notification Act (WARN), you are hereby notified of a planned employment loss in the form of a layoff, as defined by the WARN Act, at the General Motors Detroit Hamtramck Assembly Plant located at 2500 East General Motors Blvd; Detroit, Michigan. Specifically, due to the reduced market demand for the Cadillac DTS and the Buick Lucerne, a layoff will begin at the end of production on December 23, 2008. This reduction of the production level will result in the permanent layoff of approximately 500 regular employees represented by the UAW International Union, Ron Gettelfinger President, 8000 East Jefferson Avenue; Detroit, Michigan; 48214.

Employees laid off by this action may be eligible to receive State Unemployment Compensation and/or Supplemental Unemployment Benefits in accordance with Exhibit "D" to the Agreement between General Motors Corporation and the UAW dated October 15, 2007.

Attached hereto, are the job titles of positions to be affected and the number of affected employees in each job classification. No bumping rights exist in this matter but affected regular employees may have placement opportunities at other GM locations.
