WARN Act Notice for Speedrack Products Group, Ltd. – Quincy, MI.

Dear Speedrack Employee:

The Federal Law known as the WARN Act, (Worker Adjustment and Retraining Notification Act), requires that when an employer has more than 100 employees and is laying off at least 50 employees at a single site of employment which could last 6 months or more the employer must give its employees what is called a WARN Act Notice.

As you know, we have laid off 45 employees from our Quincy location starting 10/27/08. Depending upon business conditions in the near future we may need to lay off additional workers within the next 60 days. Additional lay offs will put us either near or over the 50 employee number, making us subject to the provisions of the WARN Act, thus the purpose of this notice.

While we are doing everything we can to avoid additional lay offs and certainly hope they won't be necessary, we are however, governed by the Federal requirements of the WARN Act and therefore must put all employees on notice of the possibility of additional lay offs in the future.
