Dear Mr. Houck:

Aurora Healthcare, Inc. has been forced to layoff a number of its employees. The dates of these layoffs are December 26, 27, and 28. Presently, there are approximately 200 workers from three of our facilities, including Detroit, Allen Park, and Highland Park, who have been affected. The name and address of each of these facilities is as listed on this letterhead. Furthermore, attached you will find a list of the employees and their respective positions. Unless there is a dramatic change in circumstances, we expect these layoffs to be permanent.

Recently, several Aurora employees elected the American Federation of State, County, and Municipal Employees (AFSCME) to act as their bargaining representative. The union has already been informed of these unfortunate circumstances. Ms. Angela Taber is their staff representative and Mr. Albert Garrett is the chief executive officer of their union.
