Subject: Notice of Mass Layoff Pursuant to the Provisions of the WARN Act,
29 USC 2107(a)

Pursuant to the "Worker Adjustment and Retraining Notification Act" (W.A.R.N.) you are hereby notified of a planned employment loss in the form of a plant closing and/or mass layoff as defined by the WARN Act, at GM Powertrain, Warren Transmissions Operations, 23500 Mound Road, Warren, Michigan. Specifically, it is anticipated that cessation of production operations encompassing the 4T65 transmissions produced and a volume reduction affecting the 6T70/75 transmissions at the Warren, Michigan Powertrain plant will commence on or about December 23, 2010. As a result of the cessation of 4T65- 4 Speed, and a volume reduction of the 6T70/75 6Speed, layoff will begin on January 3, 2011. The elimination of 4 Speed 1st shift and 6 Speed volume reductions will result in the permanent layoff of approximately 277 employees represented by the UAW International Union, Bob King, President, 8000 East Jefferson, Detroit, Michigan 48214.

Employees laid off by this action may be eligible to receive State Unemployment Compensation and/or Supplemental Unemployment Benefits in accordance with Exhibit "D" to the Agreement between General Motors LLC and the UAW dated October 15, 2007. For hourly employees, bumping rights do exist under the local collective bargaining agreement.

The currently anticipated hourly job classifications and the number of employees to be impacted are attached.
