Dear Provider:

In the fall of 2012, the Michigan Department of Community Health (MDCH) will change the enrollment status of beneficiaries that have both Medicaid and Children's Special Health Care Services (CSHCS) from excluded to mandatory enrollment into a Medicaid Health Plan (MHP). This means that beneficiaries with both Medicaid and CSHCS will be required to join an MHP in their county. Beneficiary communications and enrollment plans for these beneficiaries are in process. There are some factors that exclude beneficiaries that have both CSHCS and Medicaid from enrolling in an MHP such as private HMO coverage (OI 89) and those beneficiaries approved for Private Duty Nursing (PDN) services.

When CSHCS-Medicaid beneficiaries are enrolled in an MHP, providers must bill the plan for payment of all covered services. Please remember to check Community Health Automated Processing System (CHAMPS) every time you see your patients to confirm their eligibility and to determine if they are enrolled in an MHP.

MDCH recognizes the value of maintaining patient-provider relationships to preserve the continuity of medical care. MDCH and the MHPs are working together to encourage relationships between MHPs and providers that currently serve CSHCS-Medicaid beneficiaries.

Enclosed is a list of the MHPs available in each county with contact information for their Provider Relations Departments. If you have patients with both Medicaid and CSHCS coverage, and you currently do not participate with MHPs, please contact the Provider Relations Departments to discuss the benefits of becoming a participating provider. When a provider has a contract with an MHP, coordination of care is maximized and this improves the outcome for the beneficiary and their families.

As part of this enrollment status change, MHPs may be requesting updated medical information for their members that are potentially CSHCS eligible. We encourage providers to submit information requested by MHPs that is necessary to determine (or redetermine) a child's eligibility for CSHCS services in a timely manner. This will greatly assist the beneficiary in maximizing their benefits and prevent any lapse in CSHCS coverage.
