

Providers have notified MDCH that they are unable to view the Level of Care Authorization detail screen while viewing beneficiary/member eligibility in CHAMPS. The Level of Care Authorization detail is most commonly used to identify name, phone number, and/or address (when available) of the health plan, long-term-care, or other types of plans/providers who are responsible for managing a beneficiary's care. MDCH has verified that the 270/271 is not affected. Providers verifying eligibility through a third party vendor like web-DENIS or MPHI are able to view the Level of Care Authorization details.

The screen in CHAMPS will be fixed as soon as possible but to avoid any further inconvenience or adversity, below you will find a list of plans and providers who have been assigned level of care authorization for beneficiaries. More details about the plans and providers are available at:
