Dear Provider:

This communication serves as the ***final notice*** to inform currently enrolled Home Help agencies that a Home Help Provider Agreement (MSA-4678) must be on file with the Department of Community Health (DCH), Medicaid program. An extension has been approved allowing providers to maintain eligibility to receive payment for services rendered through **January 31, 2011**. Home Help agency providers must submit a completed and signed Home Help Provider Agreement (MSA-4678) to the Department of Human Services (DHS) before **February 1, 2011**, or eligibility for payment for services rendered after January 31, 2011, will be terminated. The provider agreement and instructions are enclosed. Once the agreement is processed by DHS, the agreement will be forwarded and retained on file by the Medicaid program.

The Department sent prior communications to obtain completed provider agreements. In June 2010, policy for Home Help agency provider agreements was released in the bulletin MSA 10-21. Providers were informed that federal regulations require all providers of Medicaid covered services to complete and sign a provider agreement that relays the responsibility of providers to comply with the Medicaid Home Help program requirements. A facsimile of the Home Help Provider Agreement (MSA-4678) was included with the bulletin.

A letter with a fill-in copy of the Provider Agreement was mailed in August 2010. The letter was mailed to the payment address of currently enrolled/active Home Help provider agencies. This gave notice that the provider agreement was to be completed and returned to the Department of Human Services (DHS) before October 1, 2010, for agency providers to continue eligibility to receive payment for services. Provider Agreement forms that include FACSIMILE or SAMPLE on the MSA-4678 are **not** acceptable documents.

Complete and return the Home Help Provider Agreement (MSA-4678) per the following:

1. Instructions for completing the Home Help Provider Agreement are included as part of the agreement.
2. Providers should retain a photo copy of the completed agreement for their records.
3. One agency agreement is valid for all counties in the State of Michigan.

Providers are reminded that they must immediately notify DHS of any changes affecting enrollment information. Failure to notify the DHS worker of any changes in provider information may result in nonpayment of services.

The MSA-4678 agreement and instructions are enclosed. To avoid a delay in payment, complete and return the agreement before January 31, 2011 to:
