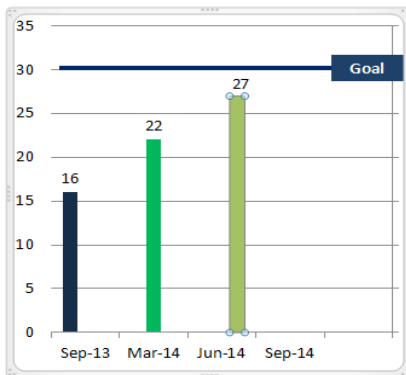




EMERGENCY CREDENTIAL LEVEL 1 (ECL 1) PROJECT UPDATE

The Michigan Department of Community Health (MDCH), Office of Public Health Preparedness (OPHP) Emergency Credential Level 1 (ECL1) Project has started to take off. Thanks to all participating hospitals for helping increase the number of ECL 1 volunteers and approaching Michigan’s goal of 25% hospital participation. The quality and quantity of “hospital-ready” volunteers is dependent on hospital participation. When disaster strikes and pre-credentialed volunteers are needed, participation helps to ensure that the needs of our hospital partners will be met. 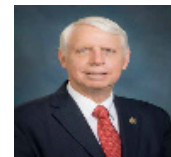
MI-TESA FULL SCALE EXERCISE IN BIG RAPIDS, MI, MAY 19 – 22, 2014

The Michigan Transportable Emergency Surge Assistance (MI-TESA) Medical Unit is a state resource consisting of a 100-bed mobile field hospital that is stored and maintained by the Region 2 South Medical Bio-Defense Network, and a 40-bed mobile field hospital that is stored and maintained by the District 5 Medical Response Coalition. The MI-TESA Medical Unit expands surge capacity, re-establishes

emergency triage, and treatment in an area where the healthcare infrastructure has been disrupted.

A full scale exercise of this state resource occurred on the campus of Ferris State University in Big Rapids, MI, during the third full week in May 2014. The Michigan Department of Community Health (MDCH) Office of Public Health Preparedness (OPHP) collaborated with three Regional HealthCare Coalitions to demonstrate the multi-disciplinary effort it takes to support a local community in a state of medical surge. Volunteers from around the state attended and participated in myriad activities to exercise this capability.

The director of MDCH, James Haveman, related in the State of Michigan’s May 2014 News Brief that: “I had the great fortune to see the Michigan Transportable Emergency Surge Assistance Medical Unit practice an exercise in Big Rapids standing up a portable hospital... Events like this support the fact that we are a department that truly takes the mission of protecting the health, wellness, and safety of our residents seriously. In these efforts, we are united.”

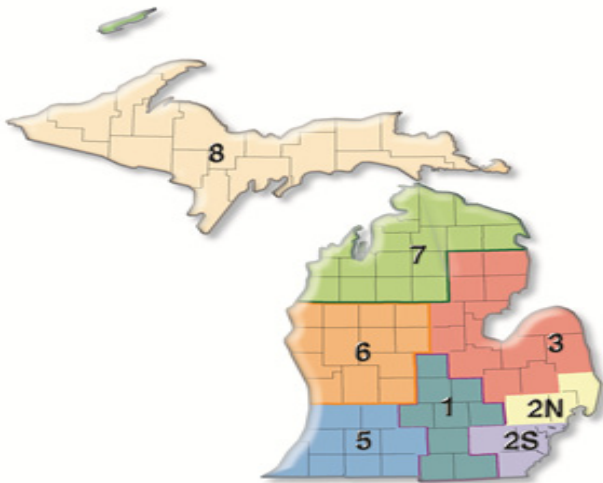

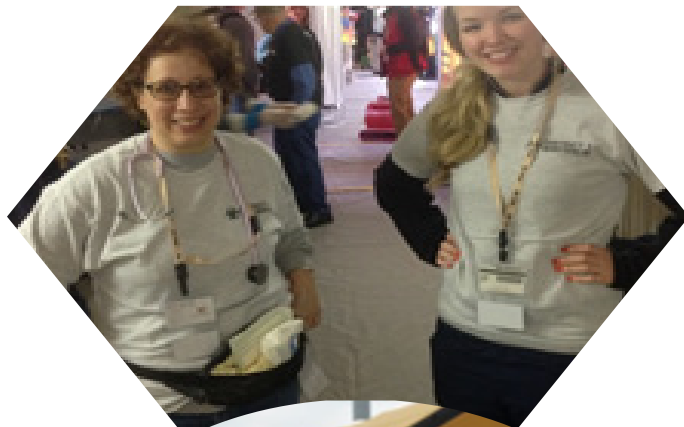
PLAYING IN THE DERT

REGION 2 NORTH MEDICAL RESERVE CORPS AWARDED SPECIAL \$5,000 GRANT

The Region 2 North (R2N) Medical Reserve Corps (MRC) has been awarded a special grant by the Michigan Department of Community Health (MDCH), Office of Public Health Preparedness (OPHP) in the amount of \$5,000. The funds in this grant will be used to help the R2N MRC collaborate with the Region 2 North Healthcare Coalition and their partners in improving our capabilities in several key areas as follows:

- Alternate Care Site: trailer set up procedures and administration staffing
- Volunteer Reception Centers/Volunteer Badging: administrator training of badging equipment in support of the organization(s) running the center(s)
- Patient Tracking: training for MRC members to assist patient tracking efforts during evacuations at hospital, long term facilities, and others as required
- Moulage Team: training for MRC members so that they may provide moulage wound simulations in support of regional exercises
- Animal Support: training for volunteers who indicate availability to care for responders' pets

The R2N MRC Coordinator, Lori Wieber, reports to the Region 2 North Healthcare Coalition Coordinator and is ready to get started on these objectives. Region 2N and Region 2N MRC will collaborate together, in conjunction with our other partners, to help us improve our preparedness and response capabilities in the region. VOLUNTEER RECEPTION CENTER TRAINING

This training afforded volunteers the opportunity to learn how to activate a VRC when a disaster occurs. The CERT members really felt like they learned what a Volunteer Reception Center is and how to implement it when needed.

Throughout the training, questions were highly encouraged and answered appropriately within the framework established by the expert CERT/MRC trainers from Region 6. The participants were asked to play a role in the VRC training to help better understand its flow. During this time, they were able to network with other CERT members in the region. The participants seemed to enjoy the training; however, they would have preferred the training to last longer in order for them to learn more techniques in setting up a VRC. Moving forward, Region 7 would like to offer an additional VRC training and include in this training a more extensive “hands on” activity based day.
