Footnotes

1. Medical Documentation forms as well as revisions to the List of Authorized WIC Formulas are available at michigan.gov/wic (*Information for Medical Providers* link).
2. In general, retail products ("R") are likely shelf stock items available via WIC grocery vendors. Institutional products ("I") may require a special order and are more likely available via WIC pharmacy vendors.
3. Purchase Quantity: WIC staff are recommended to assign formula amount in multiples of the quantities listed here, when applicable. Example: A formula with a monthly maximum of 113 cans, that is only available in a 6-pack (Purchase Quantity = 6), would result in a maximum purchase quantity of 108.
4. RTF formulas, when available in other forms, require one or more of the following conditions for issuance: documented unsanitary or restricted water supply, poor refrigeration, and/or caretaker difficulty in correctly diluting powder or liquid concentrate formula.
5. These formulas require a qualifying condition of prematurity. Additional policy requirements are contained in MI-WIC Policy 7.03.
