MDHHS Outpatient Prospective Payment System Reduction Factor History

Reimbursement to outpatient hospitals, including off-campus satellite clinics, rural emergency hospitals, hospital-owned ambulance services, freestanding dialysis centers, comprehensive outpatient rehabilitation facilities (CORFs), rehabilitation agencies for outpatient services, and ambulatory surgical centers (ASCs) is made in accordance with Medicaid's Outpatient Prospective Payment System (OPPS). No facilities (i.e. critical access or children's hospitals) are excluded from Medicaid's Ambulatory Payment Classification reimbursement methodology. Payment made under OPPS is calculated utilizing current Medicare rates, with a MDHHS reduction factor applied, unless otherwise noted in Outpatient Section of the Medicaid Provider Manual, Hospital Chapter Appendix. Effective January 1, 2020, separate OPPS reductions factors are established for Critical Access Hospitals (CAHs) and non-CAHs.
