

## Client Agreement Language

New language required by USDA:

Notification to clients of new definitions for program fraud and abuse

## 2. What does WIC expect from me?

**Buy WIC approved foods:** I will buy only the authorized foods listed on my WIC benefits. I will use WIC foods only for the person(s) on the program. If I share custody of my child or children, I will make sure that the WIC food is shared for my children.

**Use WIC benefits correctly:** I will only use WIC benefits and/or EBT cards authorized to me. I will not sell, trade or return the food or formula purchased with WIC benefits for cash or other unapproved items. **I will not post foods for sale on the internet or in other media or verbally offer to sell them.** I will handle my WIC benefits with care. I understand that I may not receive a replacement for the benefits if they are lost or stolen.



**Common Courtesy:** I will treat WIC and grocery store staff and property with courtesy and respect. I understand that I, or one of my proxies, can lose my WIC food benefits by verbally abusing, harassing, threatening or physically harming a WIC staff member, client or grocery store staff **or farmers.**


## Electronic Project FRESH Pilot

Christopher Bendekgey and State staff evaluated Year One of the pilot. System changes resulted:

- MI-WIC will enforce WIC Project FRESH can not be issued to infants, terminated clients, or above the maximum benefits per family (\$60)
- A report was developed of class attendees that were NOT issued Project FRESH benefits, with the reason not issued
- A "Print Shopping List" button will be added to the Classes screen
- WIC Coordinator will have capability to set family limit at \$30 or \$60
- Ability for State staff to assign WIC Project FRESH benefits to EITHER specific clinics OR to the Local Agency
- Report developed to show WIC Project FRESH benefit redemption by client









Nutrition Education History Tab
