Scheduling the BEI TEP: All test applications and payments must be mailed to the address on the application form. The State Cashier's Office is responsible for initial processing and deposit of payments. Test applications are then returned to the Division for final processing. This may take up to 10-14 business days.

If a submitted application does not include all required information, documentation and/or payment(s), it will **NOT** be processed until it is complete. Once applications have been processed, the Division will email applicants notification to schedule a test date. Allow at least 30 business days for processing. **Applicants may not switch test dates after receiving confirmation of their scheduled test date.**

Scheduling the BEI performance test: The Division will mail a letter to applicants regarding their TEP results. **After** receipt of this letter, applicants **must** email Alayna Zerlentes at ZerlentesA@michigan.gov to schedule their performance exam.
