SUBJECT: 2014-15 Section 31a Estimated Allocations

The 2014-15 Section 31a Estimated Allocations for eligible Local Educational Agencies (LEAs) are posted on the Office of Field Services (OFS) website under Tools & Resources, Program Allocations, at: <http://www.michigan.gov/ofc>.

Unlike the past years, there is no formal Section 31a application process for new Public School Academies (PSAs) to describe the program they intend to fund.

All eligible LEAs will be required to submit a 2014-15 Section 31a Program Report in MEGS+ on **July 15, 2015**. The form and content of the Section 31a Program Report will be determined and disseminated to LEAs at a later date.
