Category VI: Models of Demonstrated Proficiency

- Category III: K-12 Data Management and Student Tracking System\*  
(Calhoun County ISD / Center for Education Performance and Information)
- Category IV: Assisting Writing Instruction Through Technology  
(Jackson County ISD)
- Category V: Educational Technology Capacity Building  
(Eastern Upper Peninsula ISD)
