Any student meeting one or more of the eligibility categories on the Section 31a Identification Criteria Worksheets must be entered as code **3060** in the MSDS "Program Eligibility Participation" section. Any pupil reported with code **3060** in at least one of the two remaining General Collections (Spring 2015 Collection ends on March 25, 2015 and End-of-Year (EOY) Collection ends on June 30, 2015) will be considered At-Risk for Section 31a accountability calculation purposes. No additional information regarding the pupils' at-risk identification characteristics is required in MSDS.

Allocations for Section 31a will not be determined by the submission of the program code and will continue to use the Supplemental Nutrition Eligibility (SNE) data submitted in the Fall General Collection.
