**MEMORANDUM**

TO: Local and Intermediate School District Superintendents and Early Childhood Contacts, Public School Academy Directors, and Head Start Grantees

SUBJECT: Family Choice and Preschool

Recruitment and enrollment for the Great Start Readiness Program (GSRP) and Head Start (HS) is currently underway and questions about the role of family choice in preschool enrollment require clarification.

The Office of Great Start encourages families to choose the most appropriate preschool placements to meet their needs as families, and to ensure the greatest opportunities for their children. In making these choices, every family must be fully informed of all benefits that they are eligible to receive and the advantages associated with these programs.

The GSRP Participant Eligibility and Prioritization Guidelines and Implementation Manual (links below) require referral of families eligible for HS services and ensure that families are fully informed of the benefits of the additional comprehensive service provision provided in addition to a part-day or school-day preschool classroom program. Conversely, we ask that local HS grantees, in compliance with the Head Start Act of 2007, enter into Memoranda of Understanding with their Local Education Agency responsible for state funded preschool that will ensure collaborative recruitment and selection of eligible children to be served by each program.

In order to create an effective coordinated system of preschool services, both GSRP and HS must fully inform families of their options and follow state and federal guidelines for appropriate enrollment of eligible children to ensure every preschool-eligible child has an opportunity to participate. Failure to provide clarity to families
