Application Reviewers.

The Michigan Department of Education (MDE) is seeking persons interested in reviewing applications submitted to the MDE by persons and organizations applying to become approved providers of SES. SES is a component of the *Elementary and Secondary Education Act (ESEA)*, as amended by the *No Child Left Behind Act of 2001 (NCLB)*. Per ESEA/NCLB, Title I schools that do not make Adequate Yearly Progress (AYP) for three or more years are required to offer free tutoring to eligible SES students.

The MDE conducts an annual application review and approval process for new SES providers. Reviewers must be able to travel to Lansing on either Monday, May 21 or Tuesday, May 22, 2012, or both, for a review session from 9:00 a.m. to 4:00 p.m. at the Lansing Community College West (LCC West).

Potential application reviewers must also commit to participate in an instructional webinar on either Thursday, May 10, 2012 from 1:00 p.m. to 3:00 p.m., or Thursday, May 17, 2012 from 10:00 a.m. to 12:00 p.m. Individuals selected to review applications will be sent webinar instructions, a sample application, the application rubric, and directions to LCC West.

Application reviewers must participate in the webinar session and attend the review session(s). Currently, approved SES providers or applicants are not eligible to review applications. If you are interested in reading applications, please complete and return the attached reviewer form no later than **April 30, 2012.**

MDE staff will contact you if you are chosen to be a reader. **A stipend and travel reimbursement will be provided to reviewers. Lunch will also be provided.**
