Spring 2015 Student Supports and **Accommodations Documents Now Available**

The Office of Standards and Assessments (OSA) has posted several new documents which have been developed to provide meaningful NEW information and updates on students supports and accommodations.

Documents include:

- M-STEP, MI-Access, and WIDA Student Supports and **Accommodations Table**
- M-STEP Math and English language arts (ELA) Read-Aloud Guidelines
- M-STEP and MI-Access Bilingual Word-to-Word Glossaries List
- M-STEP, MI-Access, and WIDA Scribing Protocol

These documents outline important changes, including:

Some supports that previously had been considered an accommodation are now considered a test administration practice. They are found on page one of the M-STEP, MI-Access, and WIDA Student Supports and Accommodations Table.

Spotlight on Student Assessment and Accountability

 A student does not need to have these practices outlined on an Individualized Educational Program (IEP) in order for a school to use them with a student or groups of students. However, if the need for a support is listed on the IEP (as a need or accommodation), it must be provided for the student.

The M-STEP Student Supports and Accommodations Table is organized by program, and separated by:

- Universal Supports Available to All Students
- Designated Supports A designation made by a teacher or administrator that works with the student; does not require an Individualized Education Program (IEP) or Section 504 plan.
- Accommodations Requires designation by an IEP or Section 504 plan; must be provided.

For students with an IEP, it is important to remember that the IEP indicates student need. If there is a support that is listed as an accommodation on the IEP, that is now an administration practice, universal support or designated support, there are no changes that need to be made to the IEP. It just means that the school must provide that support to the student.

WIDA Test Exceptions and False LEPs

A new process has been created for administrators to request test exceptions, or waivers, from the WIDA ACCESS for ELLs or WIDA Alternate ACCESS for ELLs for English Learner (ELs).

EL students that are also Students with Disabilities (SWDs) or students who were incorrectly designated as Limited English Proficient (LEP) may qualify for a test exception.

Spring 2015 Michigan Merit Examination - ACT Plus Writing and WorkKeys Accommodations Summary Table

The Spring 2015 Michigan Merit Examination (MME) consists of the ACT Plus Writing, three ACT WorkKeys® tests (Reading for Information, Applied Mathematics, and Locating Information), and M-STEP for English language arts, mathematics, science, and social studies.

Student Test Taking Requirements for the Michigan Merit Examination

The complete MME includes ACT Plus Writing; WorkKeys; and the M-STEP ELA, mathematics, science, and social studies tests. To respond to recent questions on students required, eligible, and not eligible to take or retake the Michigan Merit Exam we have developed the chart below.

January 2015

- January 5, 2015: Deadline to submit Student Record Maintenance (SRM) files through MSDS to be reflected in the Spring 2015 M-STEP Pre-ID load.
- January 9, 2015: Last date to Pre-ID students for ACT Plus Writing and WorkKeys to receive preprinted barcode labels. Schools will be required to print barcode labels for students pre-identified after January 9, 2015 – 5:00 p.m.
- January 9, 2015: Last date to Pre-ID students for WIDA. The student's barcode number will be required to be bubbled on the student's answer document for students pre-ID in the Secure Site after January 9, 2015. Student barcode labels cannot be printed from the Secure Site for the WIDA assessment.

It is also the last day to order WIDA Braille and enlarged print materials on the secure site. Once the Pre-ID window closes on January 9, 2015, all orders will need to be placed directly with MetriTech (WIDA's material vendor).

January 6-13, 2015:

- Test coordinators confirm ACT Plus Writing enrollment number.
- Order WorkKeys standard time and accommodated materials via the ACT Establishment and Ordering system (OTIS).

Recently Asked Questions

I understand there will be performance tasks at each grade, and that there will be performance tasks in both ELA and Math.

In an earlier Spotlight, I read that schools have the option of not administering the performance tasks to students in grade 11 due to the Michigan Merit Examination legislation that prohibits the requirement of students being assessed more than one extended response item. Does this grade 11 option apply to both Math and ELA?

Performance Tasks (and their accompanying classroom activities) are recommended but not required for students in grade 11, as state law prohibits the requirement of more than one extended-response item on the Michigan Merit Examination.

However, because a single extended response item is likely insufficient to achieve alignment to Michigan's high school standards, it is unclear whether the U.S. Department of Education will allow results without Performance Tasks to count for accountability purposes.

Can you specify what the consequences might be if schools/districts decide not to administer the performance tasks?

How will this affect setting cut scores?

How will this impact the school's and district's Accountability calculation?

At this time, the consequences of not administering the performance tasks in regards to school and district accountability are not known. MDE is awaiting guidance from the U.S. Department of Education which should clarify required assessment components under NCLB Flexibility.

When administering paper/pencil assessments, can students test at different times of the day or do schools need to test all students at the same time?

Schools administering the M-STEP via paper/pencil must administer each test part on the date specified in the paper/pencil testing schedule at http://www.michigan.gov/documents/mde/Spring_2015_Testing_Schedule_Update_464310_7.pdf.

The school can determine the time to begin the test administration on the specified date, but all students in the building must test at the same time.

Recently Asked Questions

How do educators prepare students for both the spring 2015 and spring 2016 summative assessments?

Over the past several years, educators have been working hard to align classroom lesson plans and local curricula with English language arts and mathematics academic standards passed by the State Board of Education in 2010. These standards will be assessed beginning in the spring of 2015.

Michigan's standards in social studies and science were adopted by the State Board of Education in 2007. State summative assessments in science and social studies are aligned to these Grade Level Content Expectations (GLCEs) in grades 3-8, and aligned to the High School Content Expectations (HSCEs) in grade 11.

While the department is in the process of selecting an assessment system to be administered in the Spring of 2016, be assured that Michigan's summative assessments will continue to measure the state's standards, and will include technology-enhanced item types that students testing online will experience this spring.
