### MDE Seeks Input from Districts on Local Assessments to Guide New Assessment Inventory Group

In the interest of reducing time spent assessing individual students, State Superintendent Brian Whiston will be creating an Assessment Vision Group. In order to provide valuable background information and guiding points for this group, the Michigan Department of Education has developed a brief district survey to gather information on local student assessments currently in use. ### M-STEP Administrator Survey Results

## Snapshot of Administrator Survey Information and Findings

In June 2015, the MDE administered a survey to Michigan educators at the school and district level who took part in planning or administering the 2015 M-STEP.

Survey questions focused on the value and usefulness of:

- M-STEP Online Administration Training Videos in providing the information and instructions needed to coordinate the M-STEP Online Administration.
- Online Tools Training (OTT) in familiarizing students and staff with the online M-STEP tools and format of new item types.
- The staggered testing window schedule in assessing all students.
- The M-STEP engine (INSIGHT) tools and designated supports and accommodations.

The survey also collected information on:

- Test administration experiences and difficulties.
- Customer technical support in various phases of test administration.
- Overall experience with the M-STEP online administration during Spring 2015.

Survey respondents filled various roles in the rollout of the online administration of the M-STEP in schools and districts. Survey responses came from Assessment Administrators (53.11%), Assessment Proctors (19.93%), and Building Assessment Coordinators (13.57%). A smaller percentage of respondents came from various district roles (12.81%).

## Key Findings:

### Online Administration Training Videos

- Over three-quarters (78%) of Building Assessment Coordinators and 73% of Assessment Administrators, Proctors, and Accommodations Providers said the training video provided the information and instruction needed to administer the M-STEP online.

### Online Tools Training

- Nearly two-thirds (62%) of respondents said the Online Tools Training (OTT) was helpful in familiarizing students and staff with the M-STEP online tools and the format of new item types.
  - More than 60% of respondents agreed/strongly agreed with statements affirming the usefulness of the tool for students and for staff.

### Suggestions to Improve the M-STEP Test Administration Schedule

Survey participants were asked, “What suggestions do you have for improving the M-STEP test administration schedule for Spring 2016?”

- The most common response included the suggestion to reduce the amount of time required for testing, thus lessening the burden placed on test-takers, computer lab/library availability, and staff.

## Kindergarten Entry Assessment (KEA) Updates

### Pre-ID for Kindergarten Students Closes September 16, 2015

Please make certain the KEA coordinator within your district has completed the pre-identification process for Kindergarten students in the Secure Site by September 16, 2015, at 5:00 PM to ensure students are loaded into the TS GOLD system.

Two steps of pre-identification must be done for KEA students on the Secure Site:

1. Each student must be pre-identified to the KEA assessment using one of the pre-ID methods, and
2. Students need to be assigned to an online testing session on the Secure Site. Step 2 cannot be completed until teachers participating in this year's KEA have completed the Inter-Rater Reliability (IRR) module.

Once both pre-identification steps and the IRR module have been completed, students will be loaded into the TS GOLD System. **Note:** Students enrolled after September 16, 2015 will not be able to participate in the KEA.

### WIDA Training Update Alert

Earlier this week, WIDA ACCESS coordinators and administrators should have received an email from the WIDA consortium announcing the availability of new training resources. The Office of Standards and Assessment (OSA) would like to alert users that these training items are *consortium-focused* resources and not necessarily Michigan-specific. While these training materials are helpful, they include references to functionality within Assessment Management System (AMS) that will not be available to Michigan users. OSA will provide more detailed information on the list of training resources that are specific to Michigan in the coming weeks.

## MSDS LEP Exit Reminder

The window to exit Limited English Proficient (LEP)/ English Learner (EL) students as proficient is available **now through 11:59 PM, September 16, 2015** in the MSDS Student Record Maintenance (SRM) 2014-15 Collection. To exit a student as proficient, districts must submit the LEP Component with LEP Exit Reason “50” along with an LEP exit date that is on or before June 30, 2015. It is important to note that any student who has not been exited as proficient during the 2014-15 school year will be considered as LEP in the upcoming 2015–16 school year.

The above message was also sent in the CEPI Announcements email to MSDS users on August 19, 2015 and September 2, 2015.

## Input Sought on New Alternate Content Standards

The Michigan Department of Education is seeking educator review and input on the draft alternate content standards for English language arts and mathematics. The draft standards form the basis of instruction and assessment of students with significant cognitive impairments. Students receiving classroom instruction in alternate content standards are assessed with Michigan’s alternate state assessment, MI-Access.

The draft alternate content standards are referred to as Essential Elements, and are aligned with Michigan’s K-12 English language arts and mathematics standards. The Essential Elements were developed by the Dynamic Learning Maps consortium with help from Michigan educators.

Michigan educators have also created “Range of Complexity” descriptions for each state-assessable Essential Element. The range of complexity serves to provide guidance on possible milestones leading up to the target Essential Element. Students will be at varying places along the range of complexity while working toward the target Essential Element.

Michigan seeks input on the Essential Elements, and in particular, the range of complexity for each of the state-assessable Essential Elements. The Essential Elements illustrating ranges of complexity are found on the [MI-Access web site](http://www.michigan.gov/mi-access) ([www.michigan.gov/mi-access](http://www.michigan.gov/mi-access)). Once on the web site, click on the link [ELA and Mathematics Essential Elements](http://www.mi.gov/mde/0,4615,7-140-22709_28463-18034--,00.html) ([http://www.mi.gov/mde/0,4615,7-140-22709\\_28463-18034--,00.html](http://www.mi.gov/mde/0,4615,7-140-22709_28463-18034--,00.html)) in the “What’s New” section.

Once on that page, you will find links to the Draft Alternate Standards for English Language Arts and the Draft Alternate Standards for Mathematics. The “Public Comment” section contains links to the surveys by content area and grade. Please review the Draft Alternate Standards for each content area and grade, and then complete the corresponding content- and grade-specific survey. Your feedback is an important step to ensure the Essential Elements and its ranges of complexity are appropriate for the student population served and show suitable levels of student progression. The surveys will remain open through September 30, 2015.
