Dear Tribal Chair and Health Director:

RE: Limit on Federal Financial Participation for Durable Medical Equipment (DME) in Medicaid

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice of intent to all Tribal Chairs and Health Directors of the request by the Michigan Department of Health and Human Services (MDHHS) to submit a State Plan Amendment.

MDHHS plans to submit a State Plan Amendment to comply with Section 503 of the Consolidated Appropriations Act of 2016, Section 5002 of the 21st Century Cures Act of 2016 and Section 1903(i)(27) of the Social Security Act, prohibiting Medicaid DME reimbursement from being higher than Medicare reimbursement for the same equipment. Effective January 1, 2018, Medicaid DME fees must be at or below Medicare's rates in order to avoid recoupment of federal financial participation. MDHHS plans to comply with the rule while maintaining current DME provider participation levels and sufficient access to services for Native American beneficiaries, tribal health clinics and urban Indian organizations. The anticipated effective date for this State Plan Amendment is January 1, 2018, pending approval by the Centers for Medicare & Medicaid Services (CMS).

There is no public hearing scheduled for this State Plan Amendment. Due to timing of guidance received and the subsequent analysis that was required, it is not possible to adhere to the sixty (60) days notification. Therefore, notification is being provided as soon as possible. Input regarding this Amendment is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS Liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual meetings for the purposes of consultation in order to discuss this Amendment, according to the tribes' preference. This consultation meeting will allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
