These forms can be submitted directly to MDOT via the Internet, or by fax at 517-241-4193 or 517-373-3707. Fax lines are available 24 hours a day, seven days a week, including holidays. The location of bids downloaded is on the 2<sup>nd</sup> floor of the Van Wagoner building, 425 W. Ottawa St., Lansing, MI 48933.
