Program News

For the Michigan Competitive Scholarship (MCS) and the Michigan Tuition Grant (MTG), verification of second semester/term enrollment <u>must</u> be submitted by Wednesday, February 15th.

The MTG fund is currently \$5 million overcommitted. It is vital that you verify enrollments and deobligate any funds that you are not using. OSG is required to report the fund status to the legislature and to reduce awards if there is an overcommitment. We do <u>NOT</u> want to reduce your students' awards.

Tuition Incentive Program (TIP)

February 15th is also the deadline for submission of second semester/term reimbursement forms. OSG recently mailed one of two letters to more than 262,000 TIP eligible students. One of the letters was sent to seniors; their letter includes the words "College Payment Authorization" to help students realize to get this letter to your office. A copy of the letter is attached for your information.

Proposed Budget for Academic Year 2012-13



OSG will administer 11 programs for students pursuing higher education. Total funding for **FY 2012-13** is \$98,226,400. The GEAR UP funding increased to cover both the GEAR UP Michigan and the GEAR UP College Day programs.

ACCOUNTABILITY REQUIREMENTS

Many aspects of the Governor's budget include additional reporting requirements. For greater transparency, private colleges and universities will be asked to comply with best practices to remain eligible to receive Tuition Grant (TG) funding. These requirements include:

- Reporting P20 longitudinal data to the Center for Educational Performance and Information (CEPI).
- Reporting the number of students that received a TG and completed a program.
- Reporting the number of students that received a TG and required remedial education.
- Reporting the number of students that received a Pell Grant and completed a program.

The independent college or university must report in a form and manner as directed by the Department of Treasury by August 31st of each year.

The legislature must approve a final budget.

MI-GEAR UP

The Workforce Development Agency/King-Chavez-Parks Initiative has received a \$23.5 Million grant through the U.S. Department of Education, Gaining Early Awareness & Readiness for Undergraduate Programs (GEAR UP). This is the third GEAR UP grant and the title is **MI-GEAR UP**. The grant will be a little more than \$3 Million during the first budget year and provide funding over seven years. This is the third GEAR UP grant received.

MI GEAR UP program goals are to:


- Educate GEAR UP students and families on the importance and accessibility of a college education.
- Provide academic support and guidance to make college enrollment and retention achievable.
- Increase student and family capacity to make college affordable, allowing students to enter the collegiate process and leverage financial options.

A limited number of educational awards will be made to MI-GEAR UP students. Unlike scholarships, the number of educational awards will be limited. OSG and the Michigan Education Trust (MET) will partner with MI-GEAR UP to offer awards to qualified students. The amount allotted for educational awards has been set at \$2.3M. OSG will administer the bulk of the awards which will be available for students in the 2017-18 academic year. MET awards will encourage students and families to save for college by serving as initial "seed money" for college to which the student and the student's family may contribute.
