BCAEO is continuing its deliverable fuel energy assistance program that provides deliverable heating fuel (propane, fuel oil, coal, wood, kerosene and heating fuel pellets) and other energy services to eligible low-income households throughout the State. The goals associated with the program are being accomplished through sub-grants to Michigan's 29 member Community Action Agency (CAA) network. The program will reduce shut-offs through preventative interventions with clients designed to develop a self-sufficiency plan and accountability structure.

**Program Details**

- Partner agency screens for eligibility
- Partner agency identifies three issues that led the low-income household to crisis.
- Partner agency enrolls client in at least one additional program to help client move toward self-sufficiency
- Partner agency utilizes statewide database to provide case management and monitor client progress
- An average \$1,000 in deliverable fuel assistance available per household

**Additional Services Offered**

- Employment assistance and training
- Income management and budget training
- Emergency and permanent housing, emergency rental, mortgage assistance, eviction mediation
- Energy education and weatherization
- Nutrition services including education
