

**Superior Watershed Partnership
2016 MEAP Grant**

Grant Award: \$1,500,000

Service Area: **SWP's Michigan Service Territory:** Alger, Baraga, Chippewa, Delta, Dickinson, Gogebic, Houghton, Iron, Keweenaw, Luce, Mackinac, Marquette, Menominee, Ontonagon and Schoolcraft Counties.

Anticipated Reach: 1,100 Households

The Superior Watershed Partnership (SWP) is working with 28 Society of St. Vincent de Paul (SvdP) Friends in Need offices across Michigan's Upper Peninsula to help struggling families pay energy bills during the coldest months of the year, become more aware of home energy conservation options, and receive the tools to improve budgeting for future energy costs. In addition, SWP will work with the five Native American tribes in the Upper Peninsula including Lac Vieux Desert Band of Lake Superior Chippewa Indians, Keweenaw Bay Indian Community, Hannahville Indian Community, Bay Mills Indian Community, and the Sault Ste. Marie Tribe of Chippewa Indians, and participating Community Action Agencies.

Program Details

- Partner agencies and the SWP screens participants for eligibility; enrolls participants in program; provides case management, assistance with energy payments, budgeting assistance, and detailed information on simple ways to cut energy costs
- Energy assistance available up to \$3,000 per household, repeat assists allowed to the same energy service provider as long as the applicant remains eligible
- Professional home energy walk through audit and associated customized home energy savings plan; available direct energy efficiency installs including compact fluorescent light bulbs, pipe wrap, faucet aerators, low-flow showerhead, and window film.
- Energy conservation education and information regarding available state and federal energy efficiency program
