ORDER

On November 10, 2003, Brad A. Brown filed a complaint against SBC Michigan (SBC) regarding lack of service and damages to his property resulting from an alleged improper installation of telecommunications equipment at his home.

On December 16, 2003, Mr. Brown indicated that he had reached a settlement with SBC and requested that his complaint be dismissed with prejudice.

The Commission FINDS that:

- a. Jurisdiction is pursuant to 1991 PA 179, as amended, MCL 484.2101 et seq.; 1969 PA 306, as amended, MCL 24.201 et seq.; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 et seq.
- b. Mr. Brown's complaint against SBC should be dismissed with prejudice.

THEREFORE, IT IS ORDERED that the November 10, 2003 complaint filed by Brad A. Brown against SBC Michigan is dismissed with prejudice.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26.
