Dear Service Supplier:

This letter is being sent to known communications service providers who may meet the criteria for billing and collecting Michigan 911 charges. The Michigan 911 Office is aware that not all communications suppliers receiving this notice may provide service in Michigan, but given the ever-changing market, our office is sending this letter to the broadest industry group possible. If you are the point of contact for more than one service supplier, a separate form must be submitted for each of the providers you represent.

As set forth in Michigan statute, MCL 484.1102 (g) communication service in Michigan is identified as:

A service capable of accessing, connecting with, or interfacing with a 911 system, exclusively through the numerals 911, by dialing, initializing, or otherwise activating the 911 system through the numerals 911 by means of a local telephone device, cellular telephone device, wireless communication device, interconnected voice over the internet device, or any other means.

Please indicate on the attached service supplier form if your company **provides service** in Michigan that meets the definition of a communication service under MCL 484.1102 (g). If your company **does not provide service** within the geographic boundaries of Michigan, please check the appropriate box in Section III B of the enclosed form.

Communications service suppliers are required to provide this information in accordance with MCL 484.1201(4):

Each service supplier in this state is required to provide each of its service users access to the 911 system. Each service supplier shall provide the Committee with contact information to allow for notifications as required under Section 714.

The information provided will enable the State 911 Office to provide notice to communications service suppliers of changes in the state and local Michigan operational 911 charges.

Please visit the Michigan Department of Treasury website at www.michigan.gov/emergency911charges to obtain the appropriate form for remitting the Michigan 911 charges.

As the State 911 Office will be moving, please submit completed forms by email. This will ensure your form does not get lost in the move between buildings. Send completed forms to hansels@michigan.gov.
