Footnotes

- (1) Applications Received is defined as the number of requests for fingerprint clearances received by the MSP for the purpose of obtaining a license to carry a pistol concealed. This number is entered manually each year.
- (2) Licensing Board Decision is based on MCL 28.425b(7)(n), which states that issuing a license would be detrimental to the safety of the applicant or to any other individual.
- (3) Information on suicides was obtained from the Department of Community Health (DCH) and compared to the concealed pistol database.
- (4) Average Cost Per Permit is based on information submitted via a survey of each county. Not all counties submitted this information.
- (5) The Mean, Median, Shortest Amount of Time for FBI Clearance, and Longest Amount of Time for FBI Clearance is based on a statistically significant sample of requests.
