In October of 2007, the Michigan State Police Criminal Justice Information Center Divisions moved their offices from the Secondary Complex to a “temporary” facility located in the Hollister Building, in downtown Lansing. This move, scheduled for only three months, was to allow for the reconditioning and refurbishing of the divisions’ offices. Shortly after the move, construction plans were announced for a new Michigan State Police Headquarters, blocks away from the temporary facility. Within days, rumors began that the “temporary” facility would be home to the Criminal Justice Information Center Criminal Records Division, and Statistical Records Division, until the new headquarters was complete.

A lot has happened over the past 28 months. The new headquarters is nearly ready for occupancy, and the Statistical Records Division has a new name – the Reporting and Analysis Division – which better reflects the mission of the division.

Both divisions are scheduled to leave their offices at the Hollister Building on February 19, 2010, and complete the move into their new offices over that weekend. The first day in their new offices will be Monday, February 22nd. The goal is to make this move with as little disruption to services as possible. However, it will be necessary to shut down the computer network on Friday, February 19th at 1:00 p.m. It is anticipated services will be back up and running by 1:00 p.m. on Monday afternoon, February 22nd.

The new MSP Headquarters is located on the northeast corner of Grand Avenue and Kalamazoo Avenue, in the City of Lansing. The physical address is:
