Romeo Community Schools (Owner) will receive sealed bids for construction of an Arsenic Removal System for Hamilton-Parsons Elementary School, at the Romeo Community Schools Administration Building, 316 North Main Street, Romeo, Michigan, 48065, Attention: Cindy Schwark, until Thursday, June 29, 2006, at 10:00 a.m., local time. No Bids will be received after that time. Bids will be publicly opened and read aloud at that time and place.

SCOPE OF PROJECT:

The Project consists of furnishing all supplies and equipment for the purpose of removing arsenic from a groundwater well supply. Mechanical and electrical work shall be required. Start-up assistance and training shall also be provided.
