

**Michigan Public Service Commission
2003 Year End Summary
Telecommunications Rights-of- Way Permits
Public Act No. 48**

Public Act No. 48 requires the Public Service Commission (Commission) to maintain “a listing showing the length of time required by each municipality to grant an application during the immediately preceding three years.” The Commission received notification of 676 permit applications during 2003. Of those 676 applications, 635 permits were issued, 54 were denied, and 7 applications were returned as incomplete. Of the 676 applications that were approved, 457 granted unilateral permits, 96 granted bilateral permits, and 123 did not specify the type of permit.

Below is a summary of the permit notifications received from municipalities in the State of Michigan during 2003.
