**Political Party Committees
 Pre and Post Convention Filing Dates and Late Contribution Filing Dates**

Candidate Committees of candidates nominated at convention for state elective office in 2010 and/or incumbent officeholders who hold a state elective office nominated at a 2010 convention are required to file Pre and Post-Convention Campaign Statements. Incumbents that are term limited or otherwise barred from seeking re-election are not required to file Pre- and Post-Convention Campaign Statements. In addition, candidates who participate in the November 2, 2010 general election are required to file Pre- and Post-General Campaign Statements. Campaign Statements are not required of committees that have been granted a Reporting Waiver.

Candidate Committees of candidates that are nominated at a party convention and/or whose names appear on the November 2, 2010 General Election are also required to file a "Late Contribution Report" if the committee receives a single contribution of \$200.00 or more during the dates indicated. Multiple Late Contribution Reports may be required as a Report is owed for each contribution meeting the requirements provided above. For further information regarding Late Contribution Reports see [Appendix G](#) of the Candidate Committee Manual. Late Contribution Reports **are** required of committees that have been granted a Reporting Waiver.

Late filing fees are assessed against committees for failing to file required filings timely.
