COMPLIANCE, FILING AND RECORD KEEPING TRAINING

The Department of State's Bureau of Elections will hold a series of instructional seminars on the disclosure obligations of candidates, PACs and other committee types seeking guidance in complying with the Michigan's Campaign Finance Act. The seminars will offer information on the organization and operation of a committee, campaign statement filing requirements, the proper handling of campaign funds and other related topics. These sessions are available to all state and local level committees. We encourage you to attend the seminar most convenient to your schedule. The training is only available to state and judicial candidate committees and other committees that file with the Bureau of Elections.
