Dear Representative Lucido:

The Department of State (Department) received a formal complaint filed by Diane Young against you, alleging that you violated the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.201 *et seq.* The investigation and resolution of this complaint is governed by section 15 of the Act and the corresponding administrative rules, R 169.51 *et seq.* A copy of the complaint and supporting documentation is enclosed with this letter.

The MCFA requires filed campaign finance statements and reports to be complete and accurate. MCL 169.233, 235. A candidate who knowingly files an incomplete or inaccurate statement or report may be subject to a civil fine of up to \$1,000.00. MCL 169.233(10), 235(6). A candidate who knowingly omits or underreports a contribution or expenditure may be subject to a civil fine of up to \$1,000.00, or the amount of the undisclosed contribution or expenditure, whichever is greater. MCL 169.233(11).

Ms. Young alleges that you failed to report expenditures related to office space.

The purpose of this letter is to inform you of the Department's examination of these matters and your right to respond to the allegations before the Department proceeds further. It is important to understand that the Department is neither making this complaint nor accepting the allegations as true.


If you wish to file a written response to the complaint, you are required to do so within 15 business days of the date of this letter. Your response may include any written statement or additional documentary evidence you wish to submit. All materials must be sent to the Department of State, Bureau of Elections, Richard H. Austin Building, 1st Floor, 430 West Allegan Street, Lansing, Michigan 48918. If you fail to submit a response, the Department will render a decision based on the evidence furnished by the complainant.

A copy of your reply will be provided to Ms. Young, who will have an opportunity to submit a rebuttal statement to the Department. After reviewing all of the statements and materials provided by the parties, the Department will determine whether "there may be reason to believe that a violation of [the MCFA] has occurred [.]". MCL 169.215(10). Note that the Department's enforcement powers include the possibility of entering a conciliation agreement or conducting an administrative hearing.

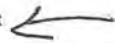



This letter is in response to your letter dated September 6, 2016, concerning a formal complaint filed by Diane Young against Peter J. Lucido.

It is my understanding and belief that Mr. Lucido rented office space to use for meetings in 2013 and 2014, and paid rent for same. At that time, he was running for State Representative in the 36th District, and rented the (non-exclusive) use of a conference room and copier on the second floor of an office building located at 6306 26 Mile Road in Washington Township. This building was centrally located within the 36th District. He had no employees, no phone service, and no personal property there. He was given an access code to gain entry to the building through its keyless entry system at the back door. He used the conference room about six times during the campaign, to meet people to solicit their endorsements. He received mail there, addressed to a pseudo suite designated as "Suite 203".

As this location was centrally located in the 36th District, his supporters would occasionally meet there, in the parking lot, to deliver/pick-up/exchange various campaign items, such as literature, signs, etc.

The rent he actually paid in 2013 and 2014 was properly reflected on his Campaign Finance Reports.

He was elected as a State Representative in the 2014 election, so he no longer needed to use the conference room at that building. He no longer paid rent, and the landlord deleted his access code to the building. Thus, after 2014, he had no personal access to use any of the facilities at that building. Some of his mail kept coming to that location. The mailman left it on a table in the lobby, next to an elevator. He would usually stop weekly to pick-up the mail, which he had to do during weekday business hours when the building was open to the public, since he no longer had the access code to unlock the doors.

Since the location of the building was centrally located in his district, even after he stopped renting, the location continued to be used by his supporters to occasionally meet in the parking lot to deliver/pick-up/exchange campaign items, but they could have met at any other place, and mostly did.

According to MCLA 169.204, to be considered a contribution, it must have "ascertainable monetary value". We contend that picking up mail and meeting in the parking lot have no ascertainable monetary value.

Elementary rules of statutory construction begin with the statute's language: If the language is clear and unambiguous, it is to be interpreted according to its plain meaning, *America Federation of State, County & Municipal Employees v City of Detroit*, 468 Mich 388, 662 NW2d 695 (2003). When interpreting a statute, both the plain meaning of the critical word or phrase, as well as its placement and purpose in the statutory scheme must be considered, *Sweatt v Dept of Corrections*, 468 Mich 172, 661 NW2d 201 (2003). In this case, the critical words in the statute are "ascertainable" and "monetary". Thus, the plain meaning of the statutory language clearly requires the thing of value to be ascertainable in money's worth before it is reportable on a campaign financial report.

In conclusion, no rent was reported by Mr. Lucido on his Campaign Finance Reports after 2014 because he did not pay any rent. Picking up his mail and use of the parking lot to deliver/pick-up/exchange campaign items has no ascertainable money value and is not reportable.

I am providing a rebuttal to Mr. Mazur defense of Mr. Peter Lucido's campaign clearly not declaring rent, whether in kind or cash expense.

Mr. Lucido's campaign website clearly references this address on 26 mile, including suite 203, so if they are surprised that mail sometimes get mailed there, it could be because for over two years they advertise this office as their campaign location. As late as this week, Mr. Lucido is advertising campaign events instructing people to mail their checks to this address. I can't imagine that the landlord allows someone to continue to advertise on the main sign on the road, in the lobby, and on a door on the second floor for free or without some form of consideration. In my humble opinion, this violates campaign finance law. I believe campaign finance rules also state that it is a violation NOT to inform the Secretary of State that your address has changed, so if in fact, Mr. Lucido is not using this office as his campaign headquarters as his attorney stated in his letter of September 19th, 2016, he should have at least changed his address with the SOS.

I have enclosed copies of mailings that have appeared throughout the year on Mr. Lucido's website and Facebook page. In addition, I am again, enclosing pictures of the signs at the road, lobby, and door. In addition, I would reference the below link, where Mr. Lucido at 6:00 into video, reference that he uses this office. This video was taken the week of August 10th 2016 where he discusses the use of the office. https://www.youtube.com/watch?v=qtsz_cm2juE. Or you can go to www.shelbytv.org

I think the appropriate response for Mr. Lucido would have been to say he misunderstood the rules and should declare an in-kind donation or pay a nominal rent. Michigan campaign finance laws are lax currently, but to allow legislators to blatantly disregard them while they are busy introducing new regulations for the rest of us to follow, is unconscionable.

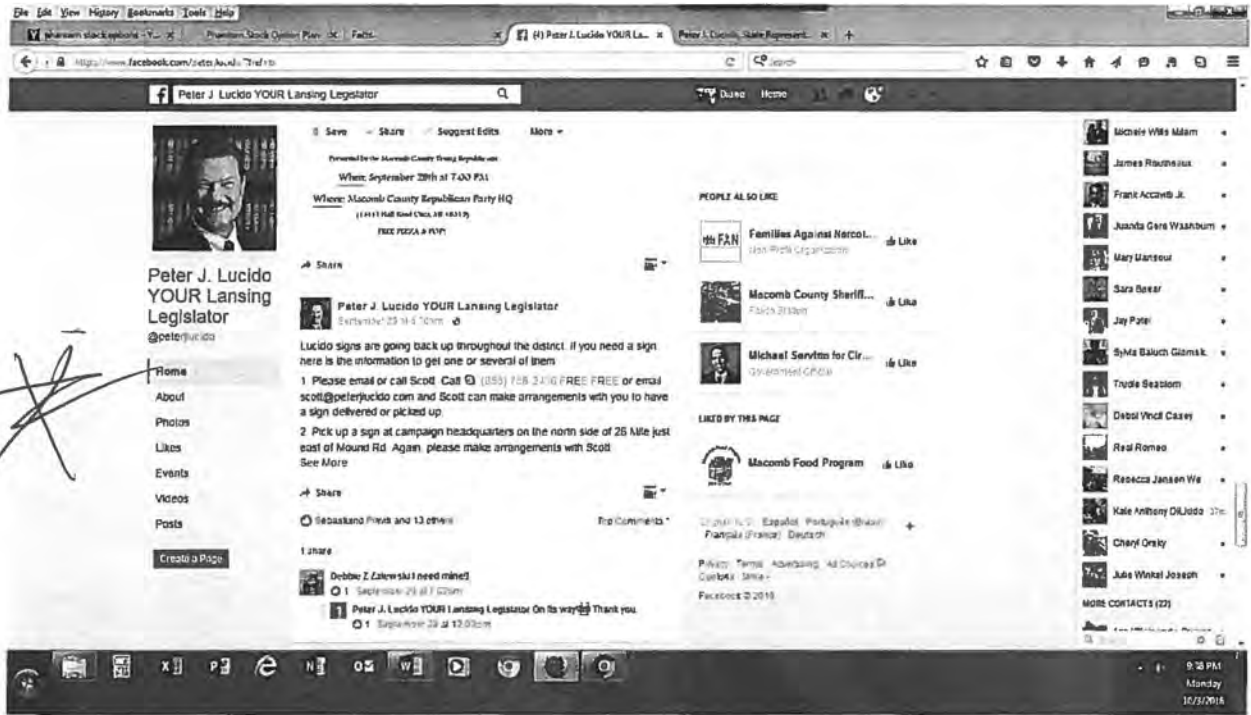





The Department of State (Department) has concluded its review of the complaint you filed against Representative Peter Lucido, concerning an alleged violation of the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.201 *et seq.* This letter concerns the disposition of your complaint.

You alleged that Rep. Lucido failed to disclose expenditures related to rent for office space located at 6303 26 Mile Road, Suite 203, Washington Township, Michigan (Office Building), on his 2015 and 2016 campaign finance statements.

You filed your complaint on August 30, 2016. David Mazur filed an answer on behalf of Rep. Lucido dated September 19, 2016, and you filed a rebuttal statement October 6, 2016. Mr. Mazur filed supplemental information at the Department's request on March 17, 2017.

In support of your allegation you provided copies of Rep. Lucido's 2014 Annual, 2014 Pre-Primary, 2014 Post-Primary, 2014 Pre-General, and 2014 Post-General campaign statements, which all disclose rent payments for office space in the Office Building. You also provided Rep. Lucido's 2015 July, 2015 October, 2016 Annual, and 2016 Pre-Primary campaign statements, which do not disclose rent payments for office space in the Office Building. You further provided a Facebook post which includes a 2015 invitation to a fundraiser for Rep. Lucido which asks for checks to be mailed to the Office Building, a 2016 Facebook post asking volunteers to "Pick up a sign at campaign headquarters on the north side of 26 mile [,]" and a printout of a website which includes a 2016 invitation to a Birthday Bash and fundraiser. This invitation asks for checks to be mailed to the Office Building.

In his answer to your complaint, Mr. Mazur explained that, "[Rep.] Lucido rented office space to use for meetings in 2014" and paid rent for that use. Mr. Mazur explained that Rep. Lucido had non-exclusive use of a conference room and copier on the second floor of the Office Building. Mr. Mazur further explained that Rep. Lucido received mail at the Office Building addressed to a "pseudo suite," and was given an access code to enter the building during that time. Mr. Mazur asserted that the rent paid for Rep. Lucido's access to the building and conference room was accurately reflected on Rep. Lucido's 2013 and 2014 campaign statements.

However, Mr. Mazur further asserted that after the 2014 election, Rep. Lucido no longer paid rent for use of space at the Office Building and the landlord deleted his access code. Mr. Mazur

admitted that mail is sometimes delivered to the Office Building, which is picked up from a table in the lobby, and because the building is centrally located in the district, "the location continued to be used by [Rep. Lucido's] supporters to occasionally meet in the parking lot to deliver/pick-up/exchange campaign items." Mr. Mazur asserted that meeting in the parking lot and picking up mail have no ascertainable monetary value.

In your rebuttal statement you provided pictures of signs purportedly at the Office Building which state, "LUCIDO Your State Representative [,]" "Suite 203 Peter J. Lucido State Rep. [,]" and "SUITE 203 Peter J. Lucido 36th District State Representative [,]"

In response to a request by the Department, Mr. Mazur provided a signed sworn affidavit from Tony J. Gallo, which states that Mr. Gallo is the manager of the entity that owns the Office Building, that Rep. Lucido has not paid any rent for space in the Office Building after 2014, and Rep. Lucido has not had use of the Office Building since he stopped paying rent.

Because Rep. Lucido no longer pays rent for use of space at the Office Building, he is not required to disclose an expenditure for rent. Additionally, "contribution" is a term of art which is generally defined, in pertinent part, to include anything of ascertainable monetary value that is used to influence or assist a candidate's nomination or election. MCL 169.204(1). In order for the Department to determine that an in-kind contribution has been made to Rep. Lucido with regard to the Office Building, there must be an ascertainable monetary value to meeting in a parking lot or picking up mail left on a table in an open area. No evidence has been offered that would show an ascertainable monetary value in connection with these activities. Because the evidence provided does not support a reason to believe that an in-kind contribution was made with regard to the Office Building, Rep. Lucido is not required to disclose an in-kind contribution for rent.

Based on the above, your complaint is dismissed.

During its investigation of a campaign finance complaint filed against Representative Peter Lucido, it has come to the Department's attention that Rep. Lucido's candidate committee (Committee) must update its Statement of Organization (S of O).

Currently, the Committee's S of O lists 6303 26 Mile Road, Suite 203, Washington Township, Michigan 48094 as its mailing and street address. However, based on the Department's review of the affidavit of Tony J. Gallo, submitted by you during the investigation of the complaint, the committee does not pay rent for, or have use of, any office space in that building. The S of O should have been amended at the time that the Committee was no longer using the office space for Committee activity.

The Department instructs the Committee to file an amended S of O by April 7, 2017.
