This letter is being issued in accordance with the Federal Worker Adjustment and Retraining Notification Act (WARN) in order to notify you that Turning Point Youth Center is temporarily closing its program located at 101 W. Townsend Road St. Johns, MI 48879. The closing will be effective July 22, 2016. This will result in the permanent layoff of 120 employees. Attached, you will find a listing of the numbers and types of jobs impacted by the closing.

Turning Point Youth Center is not part of a union. Therefore, bumping rights for employees are not an option.

At this point in time, all affected employees have been notified of the closure.
