To the Office of Workforce Investment Act,

On September 4, 2015, Aramark Corporation ("Aramark") was informed that its contract with Fiat Chrysler Automobiles will be ending and we will no longer provide food service management, or any other services, at Chrysler in Auburn Hills, MI. As a result, Aramark will permanently cease its operations at Fiat Chrysler Automobiles on December 1, 2015 and permanently terminate the employment of its employees assigned to duty at such facility on such date.

Accordingly, we are sending you this notice to satisfy the requirements of the Federal Worker Adjustment and Retraining Notification ("WARN") Act, 29 U.S.C. § 2101 et seq. While we have not determined that WARN is applicable to this closing, we are providing this notice in the event that WARN is deemed to apply. WARN requires that we notify you of the following:

1. As a result of the cessation of services described above, Aramark expects to permanently terminate its employees at Fiat Chrysler Automobiles affected by this cessation of services. Aramark expects to operate as normal until the effective date.
2. The specific job titles of our employees affected by this cessation of services, as well as the number of our employees in each job classification, are listed on the attachment to this notice.
3. Please note that to the best of our knowledge the new operator may be offering most, if not all of the former Aramark employees employment.

- 4. Certain employees that are members of the Teamsters Local 337 will have bumping rights. There are no bumping rights applicable to the other employees working at this location.
- 5. Some of the employees affected by the cessation of Aramark services are represented by unions. The name of each union representing our employees affective by this cessation of Aramark services and address of the chief elective officer of each union is as follows:
