





#### **MOTION**



RESOLVED, that the Michigan Independent Citizens Redistricting Commission (MICRC) hereby grants the Communications and Outreach Director the authority to negotiate AV contracts for Public Hearing facilities that do not have an AV team or contractor on staff, and grants the Executive Director authority to execute such contracts in order to conduct the first round of MICRC public hearings, in accordance with the Policy for Approval of Expenses adopted on January 7, 2021 in Resolution 2021.01.03, and pursuant to the budget adopted on March 11, 2021 in Resolution 2021.02.13.
