MOTION: Leave "partisan considerations" in "Non-Discrimination" section of the Employment Contract. Motion by Commissioner Curry. Supported by Commissioner Kellom. Chair Lett held a vote by show of hands. BY A VOTE OF 6-2-4 MOTION FAILED.

MOTION: Chair Lett called for a motion to remove the words "partisan considerations" in section 4.5, "Non-Discrimination", of the Employment Contract. Motion by Commissioner Lange. Supported by Commissioner Lett. Chair Lett call for a roll call vote.
